Around 2,000 transactions are reported by directors and senior managers across global markets each day. Whilst most trades are simply noise, a useful minority have real insight.

Alongside data from the transaction announcement we also supply important other features to give clear context. These factors, when drawn together, offer a source of alpha, developed and proven through quantitative historical analysis.

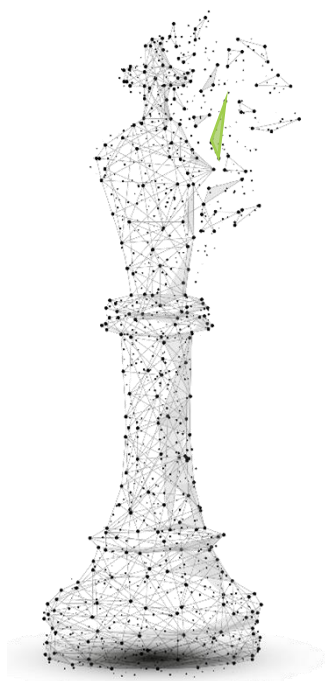
Smart Insider's Desktop Service converts insider transaction data from something interesting to a real source of investment insight & influence.

Analysts consider multiple factors when making a ranking decision, including the insider's historical track record, the share price performance and the behaviour of other insiders.

Our analysis focuses on the insider transaction and does not consider factors such as valuation or business fundamentals. We leave that to our clients.

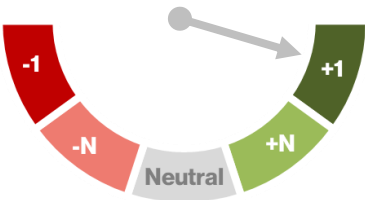

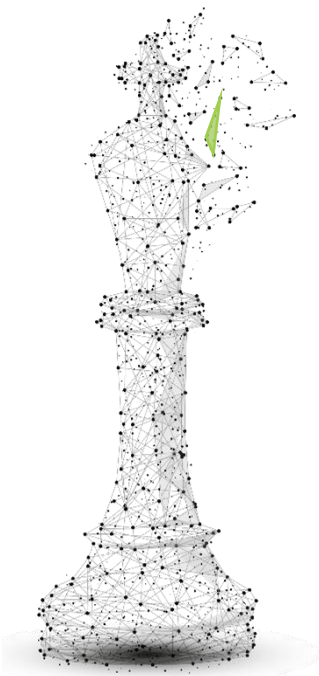

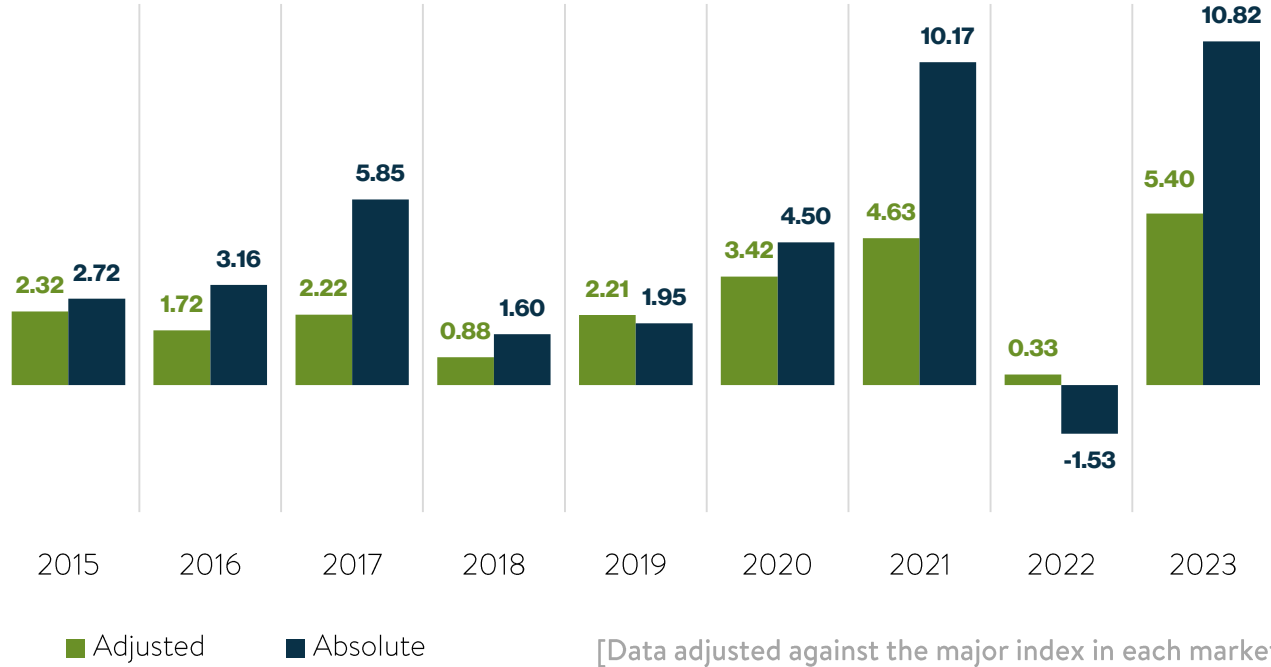

BUYBACKS

We analyse announcements of both Intentions and actual Trades which can, in combination with insider activity, highlight notable trends. Dates, amounts, volumes of shares repurchased, and intentions are all grouped conveniently by timeline to give clients tangible insight.

Examination of insider trading during a period of Buyback activity can offer greater insight and outperformance.

MICRO & MACRO

Insiders are typically contrarians, in particular at times of market volatility such as March 2020, or October 2008 when we saw record insider buying. Our aggregated data can provide valuable insight into insider sentiment at the company, sector and regional level through tools and charts to monitor Buy / Sell ratios.

ESG / GOVERNANCE

The correlation between strong governance and long-term share price performance is well established. An Insider's share ownership and activity is a way to assess the alignment between management and shareholders. We include additional information not available in source announcements such as absolute shareholding, compensation and an individual's historic roles, allowing us to create reports on management and director changes.

QUANT DELIVERY

Our data is used by quantitative & quantamental analysts for historic back testing and ongoing delivery. Company identifiers and corporate action fields make it easy to back test and integrate with existing models or secondary data sets. Our derived fields help clients find alpha. Delivery options encompass intra-day and point-in-time.
